WASHINGTON -The Obama administration is reportedly nearing a decision on its "flexible" counterterrorism policies, which could include a possible lessening of the so-called "enhanced interrogation" techniques used on prisoners at the U.S. prison in Guantanamo Bay, Cuba. The practice is now prohibited by the Military Commissions Act of 2009 (MCA) signed into law by President Barack Obama, which also made it illegal for the U.S. Central Intelligence Agency to employ such methods. The Bush administration carried out waterboarding as a means of questioning prisoners held at Guantanamo. It also authorized the use of "stress" positions for the same purposes. They were widely criticized by human rights groups as torture. "I can't discuss the details of any internal deliberations, but what I can say is that there's no change in the process," says one former Bush administration official familiar with the debate, speaking on condition of anonymity due to the political sensitivity of the issue. "We're still reviewing the various options and making our final decision based on the information we get through the process." Speculation about such a possibility has been rife for several months. Obama has set a firm deadline of January 2010 for closing the Guantánamo detention camp. Since his election in November, the president has repeatedly said that he would not allow any of the prison's 166 inmates to be released without trial. He did, however, repeatedly say that he would look for "common-sense" ways to deal with the prisoners — a
